To all to whom these presents shall come, Greeting:

WHEREAS, In pursuance of the provisions of the Revised Statutes of the United States, Chapter Six, Title Thirty-two, and legislation supplemental thereto, there have been deposited in the General Land Office of the United States the Plat and Field Notes of Survey and the Certificate of the Register of the Land Office at Los Angeles, California, accompanied by other evidence whereby it appears that the Sterling Borax Company

has entered and paid for the Red Rock, Bellflower, Red Rock Extension, Bellflower Extension, Colemanite No. 2, Belmont, Opal No. 4, Pandermite No. 2, Union No. 1, Belmont Extension, Pandermite No. 4, Pandermite No. 3, Sera Dod No. 6, Borate, Pandermite No. 1, Colemanite No. 1, Sera Dod, Sera Dod No. 2, Sera Dod No. 4, Sera Dod No. 1, Sera Dod No. 5 lode mining and Bellflower mill site claims, designated by the Surveyor General as Surveys Nos. 5336 A. and 5336 B., respectively, embracing a portion of Sections twenty-seven, twenty-eight, twenty-nine, thirty-two and thirty-three in Township five north of Range fourteen west of the San Bernardino Meridian, in the San Fernando Petroleum Mining District, Los Angeles County, California, and bounded, described, and platted as follows: Beginning for the description of the Red Rock lode claim, at corner No. 1, a pine post four and five-tenths feet long, four inches square, marked RR - 1 - BF - 1 - C2 - 1 - B - 1 - 5336 A., with mound of earth and stones, from which the southeast corner of Section twenty-nine in Township five north of Range fourteen west of the San Bernardino Meridian, bears south sixty-eight degrees eighteen minutes east six hundred twenty-three and sixty-two-hundredths feet distant;
