Know all Men by these Presents, that we, the undersigned, have this day associated ourselves together for the purpose of incorporating, under the laws of the STATE OF CALIFORNIA, a CORPORATION, to be known by the corporate name of

Star Oil Works Company.

And we hereby Certify, that the purposes for which this Corporation is formed, are

To buy; sell; mortgage; lease; locate; work and generally deal in and with Petroleum or other lands. To bore; work and mine for, and to reduce, refine; buy and sell petroleum and other oils, and to acquire such property and reduction or other works as may be required in, and are incident to said business and generally to conduct a business of dealing in oils and all things incident thereto.

That its Principal Place of Business shall be in the City and County of San Francisco, State of California

That the Time of its Existence shall be fifty years from and after the date of its Incorporation.

That the Number of its Directors or Trustees shall be Five and that the names and residences of those who shall serve until the Election of such officers and their qualification, are
