Articles of Incorporation
of the
California Star Oil Works Company

Know all Men by these Presents, That we the undersigned who are citizens of the State of California do hereby voluntarily associate ourselves together to form a joint Corporation under the laws of said State.

And do hereby Certify, First, That the name of said Corporation shall be "California Star Oil Works Company"

Second, That the purposes of said corporation is formed ^{for which} is to buy sell mortgage, ~~and~~ ^{lease} locate, work and generally deal in and with Petroleum or other lands, To bore work and mine for, and to, reduce, refine, buy and sell Petroleum and other oils, and to acquire such property and reduction or other works as may be required in and are incident to said business and generally to conduct a business of dealing in oils and all things ^{incident} ~~to~~ ~~the~~ ~~same~~

Third, That the place where the principal business of said corporation is to be transacted is the City and County of San Francisco State of California

Fourth, That the term for which said corporation is to exist is fifty years.

Fifth, That the number of the Directors of said Corporation shall be five, and the names and residence of the Directors who are appointed for the first year are as follows to wit:
